Sarah Carlson is a 2025 Mt. Hebron High School graduate, where she consistently demonstrated academic excellence by achieving Principal's Honor Roll or Honor Roll each quarter. Her accomplishments include winning first place in the short story category of the Howard County Young Author's Contest and being named student of the month three times. She was also selected as a member of the Howard County High School's GT Chorus. As a leader, Sarah established the Educators Rising organization at Mt. Hebron High School and was selected as its president for two years. HEART'S GENERAL MEETING MINUTES- submitted by Janet Zimmerman,

Addie Kaufman, Co-President, called the meeting to order at 12:02 pm. The meeting was held at The Meeting House in Oakland Mills. 98 members registered for today's luncheon. Today's meeting is our last meeting of the 2024-2025 year.

General Business and Committee Updates Approval of March 11, 2025 General Meeting Minutes

Janet Zimmerman, Secretary, stated that the minutes of the meeting were published in the April newsletter. There were no questions or corrections. **Darla Scharf** made a motion to approve the minutes; **Patti Neidig** seconded the motion. Members voted and the minutes were approved.

Treasurer's Report: Ellen Hill, Treasurer, reported the current balances: Checking = \$33,184.88; other interest-bearing checking (savings) = \$7,183.70; Scholarship = \$1,748.78. Some checking account money will be used in the near future to subsidize scholarships.

Budget

Sharon Kramer, Budget Manager, presented the proposed budget for FY26. Revenue baseline total is \$45,040.00. Expenses are budgeted at \$45,040.00, providing for a zero-based budget. Five (5) scholarships are included. There were no questions. **Sally Ann Cooper** made a motion to adopt the budget; **Debra Deere** seconded the motion. Members voted and the budget passed.

Guest Speaker

Emily Leclercq from The Howard County Office of Aging & Independence (under the Maryland Department of Aging) provided information on MD Access Point (MAP). MAP can help older adults explore options, learn about resources, connect with community, and plan & prepare. Information provided by MAP includes: short and longterm planning, transportation options, in-home care options, alternate community living options, aging in place resources, legal resources, caregiver resources, health and wellness options, 50+ center and local day programs, and benefits eligibility assistance. Options Counseling includes planning for long-term needs including knowing your options, planning wisely, and taking action before a crisis happens. It is for older adults, family/friends who provide care, and for those being discharged from the hospital or rehab with long-term care needs. It allows older adults to understand options so they may prepare financially for the costs, make sure loved ones understand their preference and goals, get organized, make decisions before a crisis, and to find services from the location where needed. Residents may contact MAP to schedule an options counseling session. Benefits screening is another service and includes: tax credits, energy screening, SNAP (food stamps), home and community-based services, housing assistance, medical assistance, and Medicare related services. SHIP (State Health Insurance Assistance Program) can help with Medicare as well as health and prescriptions drug plans questions and needs. Health and wellness programs include: Living Well (Chronic Disease self-management; Diabetes self-management), Seniors Together (peer support groups), Nutrition & Lifestyle counseling and exercise consultation, Stepping On and fall prevention programs, regular offering of exercise and other activity-based programs at the 50+ Centers, and volunteer opportunities. Howard County now has six 50+ Centers, each with a fitness center. They are the hub for all senior services. Each center is different. Hours have been extended to 8:30-7:30 and Saturdays until 12:00. Each center has its own newsletter, available on the website (www.howardcountymd.gov/CLP). Membership is free, although some programs and activities require pre-registration. There is availability of a nutritionist and exercise specialist, both for a small fee. A new program, the Older Adult Home Modification Grant, is a service that may assist older adults in modifying their home for better accessibility and safety. Guidelines are on the website. Howard County residents have availability of The Loan Closet of Howard County for durable medical equipment. There is a showroom to help with ideas for individual needs. Low vision equipment is included. There is also a Caregiver Support Program, a program for Brain Health and Dementia Education (MD has the highest incidence of dementia in the US). Other programs include a Digital Inclusion (technology) program and the Maryland Senior Call Check Program. Emily provided hard copies of the Howard County Office on Aging and Independence Resource Guide for Older Adults, Persons with Disabilities and Caregivers from the Office of Aging and Independence. It is also available online. The website was recently updated. MAP Phone number = (410) 313-1234 and is available Monday - Friday from 8am to 5pm.

The texts will urge you to click a link where you are prompted to share payment info
