# Varying Rates for Retirees July COLA

ELIGIBLE PAYEES (retirees and beneficiaries) of the Maryland State Retirement and Pension System will notice an increase in their monthly allowance beginning in July as the 2023 cost-of-living adjustment takes effect.

This year's cost-of-living rate is 8.003%. However, because this figure exceeds the rate caps prescribed in state law, most retirees will receive a reduced COLA rate for some or all of their benefit. The Retirement Agency pays benefits under several retirement systems. There are plans for teachers, employees, police and other groups. Different COLA laws apply for each system.



Employees' and Teachers' Pension Systems

3% on the portion of the allowance based on creditable service earned before July 1, 2011, and 1% on the portion earned on or after July 1, 2011.





# General Business Meeting- By Janet Zimmerman - 5/16/2023

#### Addie Kaufman and Sue Mascaro,

Co-Presidents, called the meeting to order at 12:35 pm. The meeting was held at The Meeting House in Columbia. 105 members registered for today's meeting.

#### **Business & Committee Updates**

Approval of the March 14, 2023 minutes which were published in the April/May 2023 newsletter. There were no questions or corrections. **Lois Savar-Rock** made a motion to approve the minutes; **Susan Sellner** seconded the motion. The members voted and the minutes, as published, were approved.–

#### **Treasurer's Report: Ellen Hill**

reported the current balances: Checking = \$22,726.28; other interest-bearing checking (savings) = \$10,105.09; Scholarship = \$2,119,78.

Sue discussed how HEART and MRSPA work together to protect two of our most important assets, our pension and our health benefits. Our last newsletter was corrected from "negotiate" to "advocate." Sue clarified that HEART advocates; it does not negotiate.

At our last meeting, members pro-vided feedback on moving HEART forward to the future. Dues were increased from \$10 to \$20 per year (our first increase since approximately 1975). We also received feedback for a more targeted and transparent budget process. Sharon Kramer, our new Budget Chair, presented a proposed budget for 2023-2024. The proposed budget is \$39,300.00. It is a zero-based budget. Each line item was reviewed. **Debra Dear** made a motion to accept the budget. Sally Ann Cooper seconded the motion. HEART has been supplementing the cost of luncheons. We anticipate that the increase in dues will cover most of the cost of future luncheons. There was a question about the need to print paper copies of the directory. There will be a survey in the next newsletter on this topic. Members passed the proposed budget.

**Susan Sellner**, Coordinator of the recruitment team, reviewed past and future plans to recruit new members including a possible future trip to Longwood Gardens.

Sue Mascaro gave special thanks to the many members who support HEART's sustainability including those who have served in leadership roles, those who continue to serve, those who have recently stepped up to the plate, and those who function as Officers. Members are encouraged to consider serving as officers. Members may wish to pair and act as co-officers. President Carla Duls and Executive Director Wanda Twigg from MRSPA addressed the membership. MRSPA's annual business meeting was held last week. HEART was the first local to submit its annual report.

Options counseling is planning for long-term needs including knowing your options, planning wisely and taking action before a crisis happens. *SHIP* is the state health insurance assistance program. The program has Medicare counselors, available by appointment. Health and Wellness programs are available at the 50+ *Centers*. There are six centers in Howard County. Each center has a wide variety of programs and each one is a little different than the others. Emily explained the Caregiver Support Program. Resources for Aging in Place are available. These include in-home care and supporting services as well as aging in place services. *The Loan Closet of Howard County* provides durable medical equipment for loan and accepts donations. The website lists equipment in stock for loan. The Maryland Senior Call Check Program provides a robocall to check on individuals each day. Howard County tax credit programs for seniors include: *Aging in Place, Senior Property Tax Credit*, and *Livable Tax Credit*.
